Application Information

Application Criteria

The BC Human Rights Clinic (the “Clinic”) provides free legal assistance and representation to individuals who have filed complaints with the BC Human Rights Tribunal. To qualify for legal services from the Clinic, you **must**:

- Have filed a complaint which has been accepted by the BC Human Rights Tribunal;
- Have a complaint that appears on its face to be a case of discrimination; and
- Be unable to obtain assistance from other sources.

The Clinic may consider any of the following factors in deciding whether to accept your application for legal services:

- Your income;
- Diminished capacity or any other physical, mental, or socio-economic limitations affecting your ability to represent yourself;
- Whether you have applied for assistance in a timely manner (within 30 days of notice from the Tribunal that your complaint has been accepted); and
- The availability of the Clinic’s resources to provide services to you.

Making your Application

Please read this information carefully when making your application for legal services from the Clinic. Any misrepresentation or inaccurate information provided on your application may disqualify you from receiving assistance from the Clinic.

Please complete and return the two attached documents **within 30 days** of receiving your Notice of Complaint Proceeding, along with all requested information:

1. the ***Application for Representation*** form; and
2. the ***Documents Checklist***.

Our intake committee will take approximately 6 – 8 weeks to assess your application and make a decision on whether we can assist you and what level of services we can provide. Until you receive confirmation of assistance from the Clinic, you will remain responsible for all steps in your complaint and meeting any deadlines set by the Tribunal.

Application for Legal Services

Before you apply for legal services from the Clinic, you **must** have the following:

- Submitted a complaint to the BC Human Rights Tribunal by filing one of the following **Tribunal Complaint Forms**:
 - **Form 1.1 – Individual Complaint**; or
 - **Form 1.2 – Complaint for Another Person**; or
 - **Form 1.3 – Complaint for Group or Class**; or
 - **Form 1.4 – Retaliation Complaint**.
- Received a letter from the Tribunal stating **Notice of Complaint Proceeding**

Documents required with your application

Before your application can be considered by the Clinic, you must provide the following:

- Completed **BC Human Rights Clinic Application Form** and **Documents Checklist**;
- BC Human Rights Tribunal **Complaint Form** as filed with the Tribunal (All numbered pages including attachments);
- Letter from the Tribunal stating **Notice of Complaint Proceeding**;
- Any amendments filed with the Tribunal (**Form 3 – Amendment**);
- All letters and documents you have received from the Tribunal or from the Respondent(s) since filing your complaint; and
- All letters and documents you submitted to the Tribunal and Respondent(s) since your complaint was accepted for filing.

Missing documents will significantly delay the application process.
